Following a visit to Bollington Town Council earlier this year you asked to be consulted about the content of the Bollington Town Plan. In your response to our Regulation 14 consultation you stated that Bollington sits within the Mersey Forest Boundary, and we have included that statement in our Plan. The Plan is now at the stage of being reviewed by a Planning Inspector and he has queried whether Bollington does in fact lie within the Mersey Forest Boundary. Please can you provide clear evidence as to whether Bollington does in fact lie within your Boundary. Is it possible that you have mixed up Bollington on the edge of the Peak District with Little Bollington near Knutsford?

The Inspector is seeking a reply by return so please can you respond immediately.
